ALERT ON ANONYMOUS COMMUNICATIONS IN SEYMOUR REGARDING PRIVATE WELL WATER

[Seymour, CT]

Naugatuck Valley Health District (NVHD) has been made aware of letters being mailed, delivered to residences in certain Seymour neighborhoods, or circulating on social media with allegations of possible contaminated private well water. The letters are signed by an anonymous citizen. Letters may have been received in July or October 2024. We understand that receiving unmarked letters with serious allegations can be alarming and cause concern or panic.

As of today, NVHD has not received any evidence or basis to support the allegations made in these letters.

NVHD enforces a Private Well Code. The purpose of this code is to protect the health and safety of the citizens of the NVHD and to assist in the enforcement of the Public Health Code of the State of Connecticut (CT PHC) by establishing standards for the construction and testing of private drinking water wells in the NVHD.

If private well water was found to be contaminated, NVHD would work in collaboration with the Connecticut Department of Public Health (CT DPH), the Department of Energy and Environmental Protection (CT DEEP), and the local municipality to reach out and inform residents of private well contamination, education about the contaminant, and guidance on testing, as appropriate.

Owners with private wells and semipublic wells are responsible for the quality of their water and are generally not required to test. However, regular testing and good practices to prevent contamination can help ensure that your well supplies you and your family with good quality drinking water. We have compiled a list of resources that residents may find helpful on the next page.
